

## SUBJECT: ALIGNMENT ON E-INVOICING & PEPPOL

Dear Customer,

As you will no doubt be aware, legislation will come into force in Belgium on **1 January 2026** requiring the use of **structured electronic invoices via the Peppol network** for B2B transactions between Belgian VAT-registered businesses.

### **Peppol status – Foresco Belgium**

We would like to inform you that **Foresco Belgium** will be ready to send Peppol invoices to VAT and CBE numbers from 1 January 2026, and we would also like to request a few key details from you.

At present, Foresco Belgium is **not yet able to connect to the Peppol network via GLN numbers**. We are actively working on this and expect this connection to be **operational in Q1 2026, with a focus on as early in the quarter as possible**.

Until then, we will continue working with our customers to ensure a correct and smooth transition towards mandatory e-invoicing.

**From 1 January 2026, we will issue invoices via a Peppol ID based on your VAT and/or CBE number. If this is sufficient for your organisation, no further information needs to be exchanged.**

**If this does not meet your requirements, we would appreciate receiving additional information** so that we can prepare accordingly and align our processes. We kindly ask you to inform us if you use one or more of the invoicing methods below:

- **GLN numbers** (within Peppol or other e-invoicing structures)
- **Self-billing**
- **Customer portals (e.g. Ariba, Basware, Coupa, etc.)**

If possible, we would also appreciate receiving:

- the name of the platform or system used;
- whether e-invoicing is already mandatory within your organisation;
